Profit Analysis and Weighted Guidelines

The government requires contracting officers to use a "structured approach" for determining the profit or fee objective in most noncompetitive acquisitions requiring cost analysis, but the Federal Acquisition Regulation (FAR) offers few specifics on how to do this.
